
IREF Christmas Wishes Come True in October!

How Christmas Impacts Children: A Letter from Jeremy Thompson

I came to Repalle this October with plans to specifically listen to some of the children's stories and hear their background histories, which ultimately brought them to IREF. In the U.S. the stories are always told and they have impact, but I felt there was a life lesson for me in hearing it directly from the students.

I asked my mother in law, Dee, to take me to the IREF-John's Elementary School and talk to three to five children so I could hear first hand the challenges that these children are facing each day. Dee had two children (siblings) in mind that she thought I should listen to first. Their names are Chandana (age 8) and Preetham (age 6). Chandana was shy, but she is the oldest sibling so she did most of the talking for herself and her brother. The story was tragic



as the father was an abusive alcoholic and the mother died of tuberculosis. After the mother died, the father abandoned them. The children were brought to the IREF campus by a neighbor who noticed the children had not been cared for in the days following their mother's death. No relatives were willing to care for them either.

Lydia Children's Home became a new home for Chandana and Preetham. Evangeline Rebba (Emmanuel's sister) has paid especially close attention to these two children because they are struggling with their loss. To see the strong emotion each child was feeling during this conversation was heartbreaking for me. I realized that I could never feel the magnitude of their loss because I grew up with so much and I didn't have a life experience to compare.



My one breakthrough moment with these children was when I was able to ask Chandana and Preetham these two questions: *Are you looking forward to Christmas this year and what did you get for Christmas last year?* Immediately, a large smile came across their faces. Preetham looked up for the first time in our conversation and said, "I got new clothes!" For that moment such a small thing as a Christmas gift broke the stream of emotions each child was feeling and it changed the direction of our conversation from extremely sad to smiles of joy.

It made me realize how perfect God's plan is to provide these children with joy that overshadows their loss. God touched my heart and I will never forget this conversation. Chandana and Preetham will be in my daily prayers and I look forward to watching them grown up here at IREF.

Financial Accountability To insure financial accountability, the IREF Board is committed to measures that guide the ministry of IREF in a capacity that is pleasing to the Lord. Further, we recognize that partners in the ministry of IREF, that work to impact the mission in India each year, have a need to be updated on current financial regulation that IREF participates to be good stewards of donations received.

- 1) An outside CPA firm audits our books annually. We have done this continuously for twenty five (25) years. These audits are available to any donor at request.
- 2) As a US 501©3 non-profit charitable organization, we annually file an IRS Form 990 (Return of Organization Exempt From Income Tax) with the IRS, which is available on the IRS website. We also file the Illinois Form 990 with the Illinois Attorney General.
- 3) We are members of the Evangelical Council for Financial Accountability (ECFA). EFCA Accreditation entitles a ministry to use the ECFA seal, but this requires us to maintain the ministry's good faith compliance with the ECFA Seven Standards of Responsible Stewardship (www.ecfa.org/Content/Standards).

We do these measures to insure that donors are allowed the appropriate tax deductions. We want every donor to know that we operate at the highest level of financial accountability and integrity.
